SMAC Highlight—Community Arts Programs Pilot Project

Provides Funds for Artists Collaborating with Social Service Organizations

The social service sector and the arts community are natural partners, working towards the same goals of healthy, thriving citizens, and sharing resources and cultures across neighborhoods. Many service organizations have long-standing relationships with populations in our region who have little access to hands on experiences in the arts, or to the benefits that come from involvement in arts education.

The Community Arts Programs (CAP) Pilot Project combines the strengths of both community organizations and the region's visual and performing artists to envision, plan and implement arts projects that have a substantial impact on the populations they serve. Projects might include an intensive multi-arts summer program; a wellness project that helps children explore self-esteem, body image and movement through dance; or an experiential theater program for cancer survivors where they create and perform a theater piece on their healing. Designing effective arts programming for citizens in our region is limited only by our collective creativity.

Based on our very successful Model Arts School District Program, SMAC will fund projects within 2-3 organizations, selecting and matching artists for the organizations through an RFP process, and providing collaborative help and professional development as needed.

TAWS: Teaching Artist Workshop Series

Local and national presenters will lead the workshops. There are also networking meetings scheduled with multiple topic tables and resources for artists to share with each other in a more informal way.

SMAC In Your Community--Art in Public Places Installs Two New Works of Art

Sacramento's public art collection recently added two new artworks to the ever growing 700-plus collection. The first artwork, by local artist John King, was unveiled on December 6 at Winner's Circle Park and Tot Lot in the heart of North Sacramento. The focal point of the artwork is a five-foot tall, stainless steel sculpture of a race horse, set atop a circular planter at the entrance of Winner's Circle Park. Additionally, steel silhouettes of race horses grace the stone walls at both sites. The artwork is titled "Run for the Roses" and honors James "Ben Ali" Haggin. Mr. Haggin is famous for breeding and training Ben Ali, California's first Kentucky Derby Winner.

The second artwork was created by Truckee muralist John Pugh and is a 29 foot trompe l'oeil mural titled Extended Family installed at the newly completed County Juvenile Hall Visitors Lobby. The mural features giant oak trees that look like they are bursting up through the ceiling of the building. When developing the mural's concept, the artist responded to the purpose of the visitors lobby, by creating a non-confrontational mural that is meant to elevate the mood of often anxious family members coming to the site. The great oaks are perfect subtle metaphors for human relationships and personal growth, known as trees of life or trees of knowledge.

Pugh's known for his trompe l'oeil, or "trick the eye" public art murals. "I have found that the 'language' of life-size illusions allows me to communicate with a very large audience. It seems almost universal that people take delight in being visually tricked. Once captivated by the illusion, the viewers are lured to cross an artistic threshold and thus seduced into exploring the concept of the piece."
